

PRIVACY POLICY

SONS EM TRÂNSITO - ESPECTÁCULOS CULTURAIS, Lda, single-member company with its head office at Av. Dr. Lourenço Peixinho nº 42 - 6º, 3804-502 Aveiro - Portugal, VAT number 506 734 579, is responsible for processing personal data provided voluntarily by Users.

Information about Users collected by SONS EM TRÂNSITO is, merely and solely, that voluntarily provided by Users for registration purposes or to contact SONS EM TRÂNSITO through the contact form.

Personal data collected through our website is used and processed in compliance with REGULATION (EU) 2016/679 of the EUROPEAN PARLIAMENT AND OF THE COUNCIL, of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

HOW PERSONAL DATA IS COLLECTED?

Filling out a form;
Subscription to the newsletter;
Direct contact with SONS EM TRÂNSITO;
Cookies.

Cookies are used to store information, thereby improving the browsing experience on the website. Cookies do not provide any type of access to personal information or to the user's computer. Cookies consist merely of information that the server places on the visitor's drive, thereby identifying the user when he/she visits the same page again, which enables this page to be more easily viewed and improves browsing by whoever visits a website.

By default, most browsers allow the use of cookies. If a user wishes, he/she may change the browser's configurations to block the use of cookies.

However, by blocking cookies, you may compromise the means by which you interact with this and other websites, and SONS EM TRÂNSITO will not be liable for any browsing or interaction problems.

WHAT TYPE OF INFORMATION IS COLLECTED AND HOW IS IT USED?

On our webpage, we collect the name and email address for use in marketing campaigns, prizes and newsletters. Only SONS EM TRÂNSITO will have access to

personal data provided voluntarily by users of this website. No personal information will be sold or supplied to other entities.

We may also collect other information about a client's experience on our website that contribute to improving our service. Client data allows our personnel to process your orders, notify you about important changes of the website's features, and enable us to disclose our products and services more efficiently. We may also periodically send emails to clients with information about our products and services, campaigns, promotions and special offers. If the client does not wish to be contacted for these purposes, he/she may at any time cancel his/her personal account on our site.

DATA CORRECTION

Users may review or update information provided to SONS EM TRÂNSITO at any time merely by contacting us and specifying the respective alteration. If users wish to completely delete the data provided on the website, to do so they must send an email to SONS EM TRÂNSITO to the general address requesting that their account and available personal data be deleted from the database.

RIGHT TO DELETE PERSONAL DATA

Note that, as the owner of your personal data, you have the right to ask SONS EM TRÂNSITO, which processes the said data, to delete your personal data without unjustified delay. Moreover, SONS EM TRÂNSITO is responsible for deleting the said personal data, without unjustified delay, when that personal data are no longer necessary for the purpose for which they were collected or processed or if consent is withdrawn.

VIOLATION OF PERSONAL DATA

If the personal data are violated, the entity responsible for processing them (SONS EM TRÂNSITO) will notify that fact to the competent supervisory authority (Comissão Nacional de Proteção de Dados) without unjustified delay and, whenever possible, up to 72 hours after becoming aware of such, unless the personal data violation is not susceptible of creating a risk to the rights and liberties of the natural persons. If the notification to the supervisory authority is not made within 72 hours, it shall include the reasons for the delay.

Whatever the personal data violation, it shall be documented by SONS EM TRÂNSITO with the following information: the facts related with the violation, the respective effects and the implemented repair measure.
